



WIRELESS EQUIPMENT COLLOCATION EVALUATION FORM PURSUANT TO 47 U.S.C. 1455(a)

Wireless telecommunication facilities are governed by Chapter 22.42 of the Cerritos Municipal Code, which is incorporated to this application by reference, and which is available on the City of Cerritos website at www.cerritos.us under GOVERNMENT » City Regulations » Cerritos Municipal Code » Title 22 » Chapter 22.42. Collocation of wireless equipment at an existing, approved wireless telecommunication facility, subject to limitations described below, may be approved administratively following the completion of this evaluation form and submittal of all items required herein, and thereafter the City has reviewed this information and determined the project to be eligible to be administratively approved.

SUBMITTAL PROCEDURE: Prior to submitting this application, please call (562) 916-1201 to schedule an appointment with City staff at the subject property, in order to identify any existing maintenance or design-related issues to be addressed in the plan submittal. Upon completion of the site inspection, applications may be submitted accordingly. Wireless telecommunication application submittals are only accepted on Mondays and Tuesdays from 8:00 a.m. to 4:00 p.m. In-person wireless telecommunication application submittals are by appointment only, and walk-in applicants will not be accepted. Appointments can be scheduled by calling (562) 916-1201. Any in-person or online wireless telecommunication project/permit submitted after 4:00 p.m. on Monday, whether online or in-person, will be deemed submitted on the following Tuesday, and any application submitted on Tuesday after 4:00 p.m. will be deemed submitted on the following Monday (or the following Tuesday if Monday is a legal holiday).

4.0 EVALUATION FORM SUBMITTAL CHECKLIST AND SIGNATURE

All of the following items must be submitted with this evaluation form in order for the application to be deemed complete.

- 4.1 **Narrative:** Written narrative describing the existing condition of the facility and what is being proposed, including an itemized description of what will be added, changed, and/or removed, as well as what will remain (if any).
- 4.2 **Plans:** Three (3) sets of paper plans ("ZD-100" level), minimum 11" x 17" size, including:
 - Site plan (must show all elements of existing and proposed project)
 - Elevations
 - Sections
 - Detailed plans
 - Color photos of existing conditions
 - Color photo simulations of project as proposed (may be 8 1/2" x 11" size).
- 4.3 **RF Compliance Report:** Submit an RF exposure compliance report that certifies that the proposed small wireless facility, as well as any collocated wireless facilities, will comply with applicable federal RF exposure standards and exposure limits. The RF report must be prepared and certified by an RF engineer acceptable to the City. The RF report must include the actual frequency and power levels (in watts ERP) for all existing and proposed antennas at the site and exhibits that show the location and orientation of all transmitting antennas and the boundaries of areas with RF exposures in excess of the uncontrolled/general population limit (as that term is defined by the FCC) and also the boundaries of areas with RF exposures in excess of the controlled/occupational limit (as that term is defined by the FCC). Each such boundary shall be clearly marked and identified for every transmitting antenna at the project site.

- 4.4 **Entitlements/Permits:** A complete copy of the most recent existing approved entitlement (Wireless Telecommunication Permit and/or Precise Plan) referenced in item 1.4 on page 1 as well as all subsequent administrative approvals.
- 4.5 **Letter of Authorization:** Property Owner's Consent to File Application (see attached) completed by the landowner of the subject property and notarized.
- 4.6 **Photo Simulations:** Submit five (5) sets of site photographs and photo simulations (minimum 8 1/2" x 11" size) that show both the existing location prior to the collocation/modification and the existing location after collocation/modification of the proposed wireless facility in context from at least three vantage points within the public streets or other publicly accessible spaces, together with a vicinity map that shows the proposed site location and the photo location for each vantage point, for comparison purposes.
- 4.7 One electronic file (in 'unlocked' searchable PDF format) of this evaluation form and items 4.1 through 4.6, inclusive, on CD/DVD.
- 4.8 Technical consultant review deposit and application fee of \$1,676, in accordance with the City's Master Fee Schedule (The unexpended portion, if any, will be refunded to the applicant.)
